

Making young people's dreams a reality

Dear friends,

I am delighted to share with you the results of our final year high school students this year. Over 250 students have scored a first division and are now eager to enter university.

As I look at their faces full of hope and eyes gleaming with dreams of a better future, I am reminded of the day we launched our Higher Education Programme in 2008. At that time I could have only imagined it would have an impact like the one we are seeing now. Slums are characterised by filth and garbage surrounding living spaces, blaring noises from the neighbourhood and large families crowded into tiny one room homes. For the children growing up amidst such deplorable conditions, the idea of getting into college and studying alongside students from well-off families was completely remote.

But I knew that these young people had incredible capacity and strength, and were capable of reaching great heights. And all we needed to do was to give them the belief that their dreams could be made possible.

Now, in 2014, we have literally hundreds of stories of successful young people from the slums. Students like Anil who show us what has been made possible with your support. And Shabnam, one of Asha's top scoring high school students, is hoping to continue the journey that has just begun.

Anil is a lively young man who lives with his parents and brother in Ravidas slum colony. By his dedication, and with the support of Asha, his story is proof of what is possible.

As he studied in high school, Asha encouraged him with regular counselling sessions, textbooks and sample exam papers. This coupled with his committed efforts helped him excel in his class 12 exams and opened up his chances of going to University.

However, Anil was indecisive about whether to study further, as his family's financial condition was not very good. His father, an auto-rickshaw driver, although very supportive of his dreams, was not able to afford his university fees.

Seeing Anil's passion and ability, Asha was able to step in and pay his college tuition fee as well as help him and his family through the complicated college admission process. After three years of studying at Delhi University, he completed a degree in commerce. Furthermore, his internship at Macquarie Global Finance Services through Asha's internship programme allowed him to add a professional edge to his qualification.

Starting to believe in his capabilities, Anil went on to study day and night for the competitive exams needed to secure him a government job. His dream came true

when he passed his exams and was appointed at the income tax office of the Government of India in 2013.

Not only this, Anil is also mentoring his younger brother Sunil, Asha topper from the year 2012, who is presently studying at one of the best colleges in the city. He wants to follow his brother's footsteps to pursue a career in finance.

Shabnam lives in Saraswati Camp slum colony. Her father is a barber while her mother works as a domestic help. She began receiving support from Asha at high school where she would attend workshops on exam preparation and stress management.

Shabnam has had to overcome numerous obstacles in her journey through school. When she was just beginning her final year of schooling, her mother was diagnosed with TB, leaving all the household responsibility on her shoulders.

Moreover, due to noise in the slum and outside on the roads next to her home, the only time she was able to study was at night. However, this too was difficult as her house is extremely congested with the entire family of seven members sharing one room. Despite these challenges, Shabnam continued to work hard and made use of all the resources that Asha provided.

Amazingly, when this year's exam results were declared, Shabnam learned that she had cleared her 12th standard National level examination with an average of 90%, including a score of 95 for Political Science, 93 in Geography and 90 in Hindi.

"My friends said that I am the topper from my community, I could not believe what they were saying. The results have given me a fresh inspiration to move ahead in life despite all the hurdles. Situations in life have made me stronger. Asha's assistance was incredible", says Shabnam.

Shabnam wants to pursue a career in Computer Science, but owing to the poor economic conditions of her family, her parents are reluctant to send her to college. With your help we will do all we can to help, motivate and counsel her parents and to enable Shabnam to achieve the dreams she has worked so hard

But their hard work can only get them so far when the financial and social obstacles remain set against them. It is my hope that churches, schools and other institutions will be able to support a larger number of students.
